There was no Road Crossing Permits – Permits available for inspection in the County Clerk's office

Roach moved to approve the Request to remove Ashley Shields as Receiving Officer and appoint Kyle Spade as Receiving Officer for Dist #4 for Alfalfa County. Request to remove Ashley Shields as Requesting Officer and appoint Kyle Spade as Requesting Officer for Dist #1 for Alfalfa County. Request to remove Justin Lucas as Receiving Officer and appoint Kyle Spade for Cherokee Rescue for Alfalfa County and Johnson seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Request to change the First Deputy for Dist #1 to Robert Kimminau for Alfalfa County and

Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Statements for Fairgrounds and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Private Property Access Easement for Dist #3 for NW 80 acres of 4-25-10 to remove trees from right-of-way and place on farmer's land and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Private Property Access Easement for Dist #3 for SW 1/4 acres of 7-25-10 to clean & shape ditch for proper water flow and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Private Property Access Easement for Dist #2 for SW 1/4 acres of 29-25-12 to remove trees blocking tanker culver and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Private Property Access Easement for Dist #2 for SW 1/4 acres of 29-27-11 to remove trees and stack on landowner's land; clean ditches; and shape draw to prevent water from crossing county road and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Agreement for Gravel between Dist #1 and Jim Guffy for gravel for FY 25-26 and Ross seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Received 2026 SAFE Grant – Sheriff Mast stated this was for \$20,000.00 for overtime pay from the State Roach moved to approve the Received 2026 SAFE Grant and Johnson seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Johnson moved to approve the Received REAP Grant for Service Trailer for fire department and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Crystal Road Reimbursement Grant update for Dist #3 – Ross stated the Grant has come in for this reimbursement of around \$338,000, but the Federal Land Access Grant has been pushed back another year. Johnson moved to approve the Crystal Road Reimbursement Grant update for Dist #3 and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

At 9:18 AM Johnson Voted to Enter into Executive Session as Allowed by Oklahoma State Statues Title 25, Section 307, Paragraph B 1 (Discussing the employment, hiring, appointment, promotions, demotion, disciplining or resignation of any individual salaried public officer or employee) discuss E-911 department employees for salary promotion and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

At 9:44 AM Roach Voted to Re-Enter Regular Session and Johnson seconded. Roach voted aye, Johnson voted aye and Ross voted aye.

Regarding executive session – discussion of E-911 department employees for salary promotion - Ross stated at this time not a good idea with bills in legislation affecting County General; this makes everything up in the air; Sheriff Mast is in charge of his budget and 911 is separate under the Commissioners; he feels like it is not a good idea at this time. Johnson moved to approve to take No Action regarding executive session – discussion of E-911 department employees for salary promotion and Roach seconded. Roach voted aye, Johnson voted aye and Ross voted aye. Nate Ross


There was no Unforeseen Business (Any matter not known about or which could not have been reasonably foreseen prior to the time of posting and which is not an emergency)
