Roach moved to approve the Blanket Purchase Orders from Jet Responders, Nescatunga Rescue, EM, Sheriff, EMS, and County General and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

There were no Road Crossing Permits – Permits available for inspection in the County Clerk's Office

Roach moved to approve the Monthly Officer Reports and Court Clerk Records Management and Preservation Monthly Report from Court Clerk, Court Clerk Preservation, Treasurer, and Election Board and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

At 9:18 Ross Voted to Enter into Executive Session as Allowed by Oklahoma State Statues Title 25, Section 307, Paragraph B 1 (Discussing the employment, hiring, appointment, promotions, demotion, disciplining or resignation of any individual salaried public officer or employee) discuss employment of Maintenance Position and Johnson seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

At 9:24 Roach Voted to Re-Enter Regular Session and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

Ross moved Take Action regarding executive session – discussion of employment of Maintenance Position by making a motion to give the Maintenance Position (Rick Price) a \$1.00/hour raise beginning with next pay period and Johnson seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

Discussion where to transfer \$20,000.00 from Assessor VI M&O to reduce school's portion of Visual Inspection – J. Roach started by stating in 2018 had our first protest which the county paid the attorney expenses; later on, the commissioners requested the attorney expenses go into VI to be split by all entities involved with that protest; she stated she received another bill on Friday from an attorney for \$14,898.00 so she won't move the money. Schwerdtfeger stated that she called six other county clerks and one assessor and none of the ones she spoke with had ever heard of transferring money out of VI. M Roach stated just leave the money in VI and stay the course.

Roach moved to approve the ODOT Form 324a for Alfalfa County ROW Parcels 1 & 2.1 JP 35426(04) and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

Johnson moved to approve the Private Property Access Easement for Dist #3 for two-acre tract in SW ¼ of 11-26-11 to place tree limbs in farmer's burn pit and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.

Roach moved to approve the Resolution Designating Interest for ARPA Funds to go into Highway Dist #4 Property Insurance account and Ross seconded. Roach voted aye, Ross voted aye, and Johnson voted aye.
