Harrold started by discussing the eight pipelines being sold in 2022 to three buyers, he went over the values of the sale allocated to the counties; and he included a map for Alfalfa County. Wisdom explained they used the cost approach to value; he stated haven't seen any financials or anything on the sale; still in litigation; and do not have enough information to change the values. Roach said in addition she had spoken with Jamil about not having information on the sale with no contract. There was more of a discussion on the sale and values. Campbell asked if there was any other discussion.

Royster moved to disapprove the 2024 Formal Tax Appeals and retain the Assessor's values and Maltbie seconded. Campbell voted aye, Royster voted aye, and Maltbie voted aye.

Campbell asked if there were any other Formal Tax Appeals, there were no other appeals.


Maltbie moved to Adjourn and Royster seconded. Campbell voted aye, Royster voted aye, and Maltbie voted aye.
