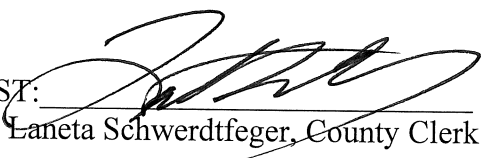

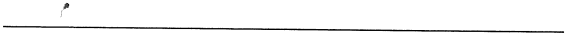
No action taken, Written Quotes for Body Cam and In-Car Camera's for the Sheriff's Office – must be bid out
