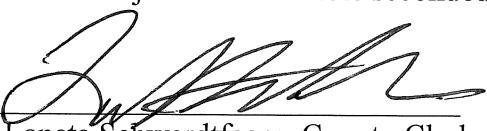
Took no action on the Appropriation for Gift Fund \$200,000.00 for Cherokee School – school did not get it signed in their meeting.

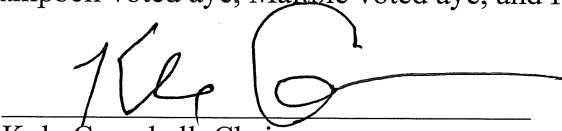

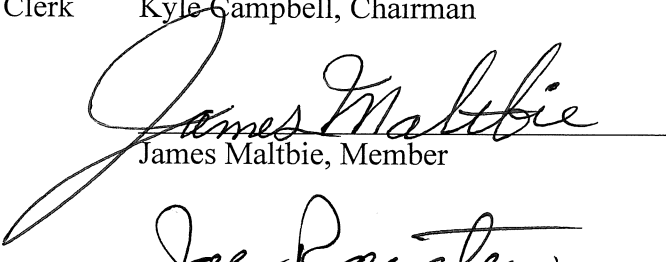

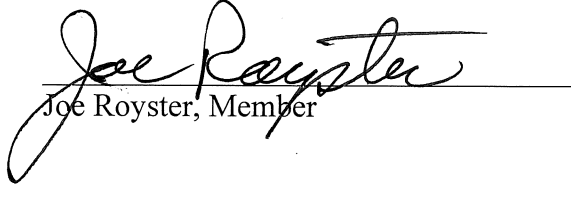
