Vice-Chairman Commissioner monthly update for Excise Board – Ross stated the districts maintaining roads between rains, Dist #1 chip & sealing the parking lot at the school, Dist #2 finishing up bridge by Carmen, Dist #3 received a \$300,000 grant for a mile and half on Crystal Road along with a Federal Grant for the Lake Access Grant of \$6 million, Courthouse working on the budget.

Assessor Update – J. Roach gave a breakdown of ad valorem tax from commercial real estate, commercial personal property, ag real estate, business real estate, farm personal property down to public service from OKC. She stated she had eighteen informal protests ending up with only one formal protest.


