Roach moved to Adjourn and Ross seconded. Ross voted aye, Roach voted aye and Johnson voted aye.



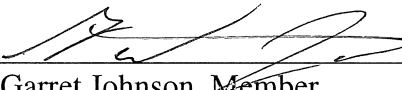
