Update for Budget for FY 24-25 – Schwerdtfeger stated Buddy Carrol, Budget Maker stated that we needed to cut \$256,000 from County General. The officers discussed at great length possible areas of possible reduction. J. Roach mentioned the possibility of changing the assessment ratio, through the vote of the patrons. Erin Metcalf was called to join the meeting, she discussed the way the "Contractual Services" amount was figured, there was also a discussion if we moved the Contractual Services to County General Sales Tax if that would interfere with the OSU Extension budget. The officers discussed until they came up with changes for the budget for County General. Ross moved to approve the changes remove Sheriff's Capital Outlay \$80,000.00; remove amount Sheriff's M&O of \$20,200.00; remove \$10,000.00 of EM Personal Services to be paid out of Grant account; remove \$34,800.00 of EM Personal Services to be paid out of County General Sales Tax; remove \$82,155.00 of the E911 Personal Services to total \$256,000.00 from County General budget and Claflin seconded. Ross voted aye, M. Roach voted aye, Johnson voted aye, Mast voted aye, J. Roach, Miller voted aye, Claflin voted aye, and Schwerdtfeger voted aye.
