The Alfalfa County Commissioners met in the Commissioner's Office at 10:00 AM for this regular meeting with Chairman Roach calling the meeting to order with members Jay Hague and Marvin Woodall, and County Clerk Laneta Schwerdtfeger present. Visitors: Christi Porter and Laura Hammontree, WIOA and Shana Wells, Emergency Manager

She stated they can not spend money on advertisement, but can put the program on social media, public service announcements and by putting on job fairs.
